Re: LHSIA s. 20 Notice and Extension of Multi-Sector Service Accountability Agreement(s) ("Extending Letter")

The Local Health System Integration Act, 2006 ("LHSIA") requires the North West Local Health Integration Network (the "LHIN") to notify a health service provider when the LHIN proposes to enter into, or amend, a service accountability agreement with that health service provider.

The LHIN hereby gives notice and advises Victorian Order of Nurses - Ontario Branch (the "HSP") of the LHIN's proposal to amend each and every multi-sector service accountability agreement (as described in the LHSIA) currently in effect between the LHIN and the HSP (each a "SAA").
